

# **KEY DEVELOPMENTS IN SERBIA**

Commissioner for Human Rights of the Council of Europe, Dunja Mijatovic, published a <u>report</u> in September 2023, following her earlier visit to Serbia, on women's rights and gender equality, among other topics. Although the Commissioner recognized the efforts of institutions to adopt laws and policies in the field of gender equality, she noted that progress in this area is very slow and is particularly concerned about high prevalence of all forms of violence against women. She called for an end to misogynistic and discriminatory statements against women. She also called to double the efforts to improve access to support and protection services for women with disabilities, Roma and migrant women, and strengthen fight against discrimination and prejudice these women are exposed to. She called on institutions to recognize the work of NGOs on the protection of women's rights and gender equality and provide them with stable funding and unequivocal support.

The adoption of the Action Plan for the National Strategy for Combating Gender Based Violence against Women and Domestic Violence 2024-2025 is still pending. National Action Plan (NAP) for the implementation of the Gender Equality Strategy 2021-2030 is also pending and so is the NAP for the implementation of UNSCR 1325 on Women Peace and Security Agenda, as previous one expired in 2020.

When it comes to international commitments, the State will go through simplified procedure for CEDAW 5th cycle. Simplified reporting procedure means: "The Committee offers States parties the possibility to submit periodic reports under a simplified reporting procedure, provided that they have submitted an updated common core document within the past five years. As part of this simplified procedure, the pre-sessional working group adopts a list of issues prior to reporting (LOIPR), in other words, prior to the submission of the State party's periodic report..." An Independent report of the SOS Vojvodina Network to the CEDAW Committee on the occasion of the Fifth Periodic Report of the Republic of Serbia, for the period 2018-2022, was published in December 2022, supported by UN Women.

To help take stock of progress and expand existing commitments to the Generation Equality initiative in the areas of innovation and technology, the Government of the Republic of Kazakhstan and UN Women hosted Generation Equality Regional Midpoint event entitled "Innovation and Technology for Women's Economic Empowerment and Gender Equality" in Almaty, Kazakhstan in November 2023. Stakeholders from various sectors were invited to assess their engagement in the Technology and Innovation Action Coalition. On this occasion, Natasa Colic, researcher from The Institute for Architecture and Urban and Spatial Planning in Serbia joined the Generation Equality Initiative as new Commitment-Maker.

Actress Milena Radulovic started giving testimony in a high-profile trial in Belgrade, telling the court how she trusted and admired wellknown drama teacher Miroslav Aleksic before he sexually assaulted her when she was 17. "It's a feeling of such betrayal because a man who I trusted so much, who was a supreme authority and who I felt in awe of, caused me such pain," Radulovic told the court. The trial continues.

# SAFER PUBLIC PLACES FOR WOMEN AND GIRLS

Within the project "Safeguarding Women and Girls in Serbia" funded by the Foreign, Commonwealth & Development Office (FCDO), a total of 12 partnerships were established with civil society organizations and local self-governments units. Out of those 12 partnerships, 10 focus on advancing safety of women and girls in public spaces in five selected cities in Serbia, where the activities implemented by the local self-governments are in synergy with those implemented by the partner CSOs. In the period from August to January 2024, here are some of the key results of our partners, accomplished with the support of UN Women's granting scheme:

• Femplatz held two workshops with women citizens of Sombor with the aim to select a model/way for the active participation of different groups of women and girls in the process of improving safety in public spaces with mapping of unsafe places in the city and proposals for solving specific problems. Also, the participants mapped unsafe places in Sombor based on which an Interactive map has been created with all unsafe places for women and girls marked.

 Association Mikser formed a Facebook Support group "Ona hoda sama kroz grad – Bezbedniji Kragujevac za sve" with an aim of giving a voice to women and girls, with the support of the local initiative of the City of Kragujevac to recognize the challenges, personal experiences, and tactics that women develop in order to felt safer and more secure in their city, but also to raise awareness about the tolerance of violence against women in all those situations where justification is found and violent behaviour is rationalized. • CSO Monitor made the Report on the conducted research on the security needs of girls

and women in selected public areas in Novi Pazar with recommendations. Within this report, 14 risks and threats to the safety of girls and women in selected 5 public areas in Novi Pazar were identified. Also, a total of 25 recommendations are given for improving the sense of protection of the safety of women and girls in selected public areas in Novi Pazar. The most important achievement is the fact that the LSGU has adopted 5 proposed measures in their LAP for Gender Equality.

• CSO Sandglass conducted a training for the officials and women's rights activists on women's safety in public places, which was according to results of pre-testing and post-testing very useful and provided new knowledge to the participants. Also, the Sandglass' representative took part in the working group's for making Local Action plan on gender equality of the City of Krusevac.

• CSO Center for Girls surveyed 241 girls and young women about how safe they feel in public spaces in Nis. Based on survey results, risk map with locations in Niš where girls and young women do not feel safe has been created in the Google maps application. The locations that the girls rated as unsafe were highlighted and marked with different colours, from red, which is the safe, to green, which is the safest.

• The City of Novi Pazar developed Local Action Plan for improving the position of women and promoting gender equality for the period 2023-2027. Regarding safety of women and girls in public spaces, 5 activities were formulated.

• The City of Nis in cooperation with Roma WCSO Osvit held a two-day workshop on the topics of "Gender equality" and "Safety in public space". The workshop was attended by 30 Roma women from 3 Roma settlements in Nis. The aim of the workshop was to bring the concept of gender equality closer to Roma women and to map the unsafe spaces in the public spaces in Nis where Roma women move.

• The City of Krusevac developed the Local Action Plan for Gender Equality of the City of Kruševac 2024-2027. The LAP contains the Special Objective 3: "Improving the safety of all citizens, especially women in the community". Furthermore, work was carried out on the installation of two reflectors at the Sveti Sava school, in rural settlement Globoder. On that occasion, the school yard was illuminated, i.e. the sports field. Finally, work was also carried out on the installation of concrete pillars, the installation of electricity and two reflectors on the newly built park in the residential area of Rasadnik.

• The City of Kragujevac has installed public lighting in the Creative Park in order to contribute to the sense of security of citizens in public place, while damaged lighting in the Memorial Park has been replaced. Also, in the locations that were mapped by fellow citizens, the schedule of bus lines has been changed.

# **ROADMAP FOR IMPLEMENTING URBAN SAFETY MEASURUES IN URBAN PLANNING PROCESS**

Institute of Architecture and Urban & Spatial Planning of Serbia – IAUS in cooperation with 7 thematic bodies was tasked with drafting measures established within the Roadmap: decision makers, police, urbanism and planning, academia, civil society organizations, utility companies and transport. Five thematic workshops served to use the "collective" professional potential of the gathered to gather ideas on the possibilities of introducing into practice the obligation to implement preventive measures for a greater degree of security and improvement of security in public urban areas, especially from the aspect of women and girls as recognized vulnerable groups of residents. The Roadmap determined two recommendations of national measures and the Roadmap was delivered to the Ministry of Construction, infrastructure and transportation which also, through its representatives, participated in the drafting of this important document.

# DRAFT OF THE ACTION PLAN FOR **IMPLEMENTATION OF STRATEGY** FOR PREVENTION AND **COMBATING GENDER-BASED VIOLENCE AGAINST WOMEN** AND DOMESTIC VIOLENCE

In order for national authorities to adopt measures to prevent and respond to gender-based violence against women and girls in public and private spaces, in close cooperation with the MOLEVSA, three measures related to improving the safety of women and girls in public space have been included in the National Action Plan: 1) Holding public events, expert meetings and conferences on protection measures against gender-based violence against women and girls, as well as domestic violence, with an emphasis on the protection of women and girls from violence in public places; 2) Formulation and launching of initiatives for gendering local planning documents related to urban planning of the city in order to ensure that the gender perspective is included in the future planning of public places; 3) Informing local self-government units about the Women Safety Audit Tool developed within the project "Safeguarding Women and Girls in Serbia" and initiating the implementation of this tool in local self-government units.

# **ASSISTANCE TO SHELTERS** FOR VICTIMS OF DOMESTIC AND GENDER-BASED VIOLENCE **IN SERBIA**

As part of the efforts to strengthen capacity of shelters for victims of domestic and gender-based violence, the Community of Practice (CoP) created within the project "Safeguarding Women and Girls in Serbia", had its fourth meeting in December 2023. At the meeting, representatives of Safe Houses had an opportunity to learn more about stalking and sexual harassment as well as the Expert methodological guidance related to visiting children with violent parent. Also, two selected CSOs (Atina and Center for Support of Women) implemented projects and improved performance and increased functional and structural capacity among all 11 functioning Safe Houses through a detailed assessment of needs among shelters, followed by technical assistance for preparation of missing rulebooks, development plans, specialized programs, security standards and organization of training for service providers. Small-scale purchase of necessary materials to facilitate the implementation of programs and improvement of quality standards of services were provided as well as a small-scale local visibility campaign.

# **IMPROVING SAFETY OF WOMEN** AND GIRLS WITH ELECTRONIC MONITORING SYSTEM

The project "Improved Safety of Women in Serbia" has been focused on enhancing the capacity of the Ministry of Justice in Montenegro to implement the electronic monitoring system of restraining order (EMS) for both victims and perpetrators of violence against women. The support from UN Women has led to the permanent employment of consultants within the Ministry of Justice-related directorates, who were initially engaged with UNW support. Additionally, UN Women has collaborated with prominent women's civil society organizations in Montenegro to conduct joint awareness-raising activities regarding violence against women and the EMS. These activities aimed to educate survivors, perpetrators, the judiciary, other stakeholders involved in prevention and response to VAWG, and the general public, about the use of EMS for monitoring restraining orders and enhancing the protection of women experiencing gender-based violence. Information sessions and workshops have been organized for various stakeholders, including women survivors, judiciary, social, police, and health service employees, as well as experts in criminal proceedings and specialized women's CSOs, to improve understanding and implementation of restraining orders and EMS in combating gender-based violence.

# **COMBATING VIOLENCE** AGAINST RURAL WOMEN

Under the project "Improved Safety of Women in Serbia," UN Women provided support to the Commissioner for Protection of Equality to raise awareness and foster confidence in rural women to recognize gender-based violence and discrimination against them and to utilize measures and authorities responsible for addressing such issues. The initiative involved capacitating eight less experienced CSOs focused on rural women and girls' human rights in the Moravica and Zlatibor regions. These CSOs received technical equipment to aid their operations, along with training to deepen their understanding of issues related to gender-based discrimination and violence against women and girls, and prevention and protection mechanisms. They were trained to serve as referrals for cases of gender-based discrimination and violence against rural women, including in online spaces. Partnerships were established with the Women's Association "Nadežda Petrovic" from Cacak and the Women's Association "Let's Save the Village" from Priboj to provide this support.

Through a comprehensive media campaign utilizing printed and social media, the Commissioner's office reached over 200,000 women and men, raising awareness about the situation of women and girls in rural areas, with a particular focus on gender-based discrimination and violence. Additionally, context-specific outreach programs and awareness-raising activities targeted rural women, including events like the Festival of Women and Girls in rural areas, commemorating Rural Women's Day, were conducted. This festival served as a platform for presenting and marketing rural women's products to enhance their economic independence. Five local events and fairs organized by local CSOs and covered by local media outlets, were supported as well. The project recognized and rewarded journalists who promoted anti-discrimination, tolerance, and equality for rural women and girls, as well as those who highlighted rural women's entrepreneurship and creativity, further contributing to the project's results.

# 2146 WOMEN ACROSS SERBIA SUPPORTED LOCAL INITIATIVES

Around 1,169 women mostly from Kolubara and Zlatibor districts improved knowledge on their rights to inheritance, received legal advice and raised awareness about negative consequences of stereotypes and patters in this area, while over 3 million people were informed about this stereotype through flyers, brochures, participation at TV shows, news and articles, produced media content not only in Serbia, but also in the region. Great results achieved by the Women's Forum Prijepolje and Women's Association of Kolubara District will continue through the work of the informal CSOs Coalition on Equal Inheritance. In total 977 women directly benefited from support, through increasing their knowledge and skills about advocacy techniques, monitoring the gender equality policies, collecting data, and advocating for evidence-based policies at the local level, as well as improving the agricultural production, while 600 women and girls are informed about their patent's rights, with an emphasis on induced abortion through human rights caravans in 6 cities in Serbia. Projects resulted in developing advocacy tools and policy documents which will serve as a basis for introducing and advocating for different initiatives at national and local level by CSOs Amity, Belgrade Centre for Human rights, Save the Village Priboj, FemPlatz, and Women's Center Uzice.

# **RIGHTS OF WOMEN AND GIRLS** DURING THE PROCEDURE OF **INDUCED ABORTION**

UN Women Serbia supported the CSO Belgrade Center for Human Rights in implementing research "Rights of women and girls during the procedure of induced abortion" including interviews with 30 women from different parts of Serbia who had the experience of induced abortion, while 165 women filled out the online survey. Research showed that "48% of the respondents stated that the induced abortion procedure was performed without the presence of health workers, despite the fact that the patients that were present and the patient on whom the procedure was performed asked for assistance. Almost half of the respondents stated that they were not informed at all about the procedure itself, the risks and the available medications or mechanisms that would help ease the pain and suffering". The research concludes that induced abortion procedure is performed in an outdated way that deviates from the latest medical advances in the field resulting in numerous painful and traumatic experiences of women. It defines 33 recommendations for healthcare institutions. Research was presented as part of the marking of 16 Days of Activism against Gender-Based Violence and through an awareness raising campaign #myrighttoknow. The Belgrade Center for Human Rights embarked on a tour of six cities in Serbia in a Caravan action. During a month of field work, 600 were informed about their patient rights. The initiative was implemented in the framework of the EU project "Support to Priority Actions for Gender Equality in Serbia II".

At the local level, UNW continued to provide support to 5 LSGUs in GRB introduction and evidence based and gender sensitive budget planning, conducting budget gender analyses of various sectors selected by LSGUs: culture and information (Topola), political system of LSGU (Trstenik), transport (Zajecar, Lazarevac and Uzice). As part of the support provided by UN Women, more than 200 members of LSGUs administration, local gender equality mechanisms and public utility companies learned more about GRB implementation and how their institutions can contribute to gender equality by closing the gender gap and reduce inequalities in their respective areas, covered by their specific mandate. In addition, 54 employes in these LSGUs (40 women and 14 men) received mentorship, comprised of individual support in identifying gender equality priorities in budget programmes encompassed by their Annual GRB Plans and defining gender sensitive budget objectives.

# **EVALUATING MEASURES** FOR BETTER TARGETING AND ADAPTATION TO WOMEN'S NEEDS

To support development of evidence-based measures and programmes, UN Women conducted the budget gender analysis of measures to support women's and social entrepreneurship, in partnership with the Provincial Secretariat of Economy and Tourism. The analysis, presented to the relevant stakeholders and the public on 28 November 2023 in Novi Sad Chamber of Commerce, showed that more women entrepreneurs are receiving support (42% of support recipients in 2021 and 2022 were women), however funds are much less than the funds allocated to men's businesses (17%), confirming the need for further improvement of public calls to respond to the different needs of women's entrepreneurs. In addition, UN Women supported the Ministry of Agriculture, Forestry and Water Management by conducting the expost gender analyses of measures in agriculture and rural development, to improve GRB application in this sector and to better target rural women with financed measures.

# SUPPORTING THE NAP FOR GE 2024-2025

In partnership with the Ministry of Human and Minority Rights and Social Dialogue, UN Women, jointly through GRB and GEF project, supported the development and costing of Action Plan 2024-2025 for the Strategy for Gender Equality 2021-2030. To ensure that the new AP is based on the results of previously conducted activities and contributes further to the implementation

of the Strategy, UN Women supported the expost evaluation of AP 2022-2023. In addition, to secure that the challenges and proposals of women's organizations are included in the proposal of activities, UN Women organized consultations with women's CSOs, gathering 14 women's CSOs.

# WOMEN, PEACE AND SECURITY

The partnership between UN Women and the Network of Women in the Police of the Republic of Serbia, as outlined in the signed Letter of Cooperation, focused on promoting gender equality, empowering women within the police force, and enhancing women's safety.

As part of this collaboration, a significant event was the regional conference "Women in Police and Leadership: Challenges and Good Practices," which took place on October 13, 2023, in Belgrade. The conference served as a platform for women in the police force across the region (from Albania, Bosnia and Herzegovina Federation, Bosnia and Herzegovina Republic of Srpska, Bulgaria, Montenegro, North Macedonia, Slovenia, and the European Network of Women in Police- Austira), to exchange experiences, discuss good practices, and address challenges encountered by women leaders in the security sector. Through interactive discussions, participants shared insights on overcoming the obstacles faced by women in law enforcement and highlighted strategies for enhancing gender equality within the sector. The conference facilitated networking opportunities and strengthened cooperation among participants through mutual support and collaborative initiatives.

A notable outcome was the signing of the Declaration on cooperation among networks of women in the police from the region, aimed at improving the position of women police officers. This declaration underlines a collective commitment to advancing gender equality, fostering supportive environments for women in law enforcement, and promoting their professional development and safety.

# WOMEN AND JUSTICE

UN Women continued its cooperation with the Ministry of Justice to enhance the capacities of the judiciary in addressing violence against women and its specific forms, in line with national and international obligations. A key aspect of this cooperation was the support provided in drafting the new General Protocol for Action and Cooperation of Institutions, Bodies, and Organizations in Situations of Violence against Women within the Family and in Intimate Partner Relationships.

Furthermore, UN Women facilitated training sessions in Belgrade and Novi Sad for misdemeanor judges and representatives of the judiciary focused on responding to domestic violence and violence against women. These workshops covered essential topics such as misconceptions and prejudices about domestic violence and violence against women, international standards, and the domestic legal framework for protection against such violence.

The workshops highlighted the significant need and interest among misdemeanor judges for training in these areas. They provided a valuable opportunity for judges to share their experiences and address controversial issues they encounter in their daily work. Additionally, the workshops highlighted the importance of enhancing the efficiency of competent authorities and the necessity for local self-government units to develop social services tailored to meet the specific needs of victims of gender-based violence.

PEER MENTORING PROGRAM FOR PROMOTION OF HUMAN RIGHTS, GENDER EQUALITY AND INCREASED YOUTH PARTICIPATION IN SERBIA

Joint project Peer Mentoring Program for promotion of human rights, gender equality and increased youth participation in Serbia implemented by UNFPA and UN Women continued in 2023. In a demonstration of youth empowerment and collaboration, young individuals from six diverse municipalities across Serbia, including Sremski Karlovci, Knjazevac, Novi Pazar, Bajina Basta, Kragujevac, and Sombor, organized a range of impactful activities centered around different social, gender and youth issues. Guided by their peer mentors from the Youth Advisory Group (YAG) of the United Nations in Serbia, these young change-makers addressed topics such as gender equality, environmental concerns, anti-discrimination, media literacy, youth engagement, and social entrepreneurship. On December 13, UNFPA and UN Women, in partnership with the Ministry of Tourism and Youth, the Embassy of Italy, and RCO, convened to commemorate the successful conclusion of the "Peer Mentoring Program for promoting human rights, gender equality, and increased youth participation in Serbia." This event celebrated the project's accomplishments and fostered collaboration among key partners to advocate for greater youth engagement in Serbia. It provided a platform for young individuals to share their inspiring success stories, amplifying their voices.

Additionally, the project's campaign, #YouthHaveTheirSay, utilized social media platforms to reach a considerable audience, generating 500K impressions and engaging over 350K individuals. This digital outreach extended the impact of the project, disseminating messages of empowerment and youthled change beyond the event itself and respective local communities.

# GENERAL

UNFPA Serbia signed a Memorandum of Understanding with the office of The Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH on 12 December 2023. The MoU will create a framework for joint efforts in advancing the implementation of various measures enhancing young people's potential by creating an equal society. UNFPA and the GIZ will continue with joint advocacy for inclusive youth empowerment and implementation of a comprehensive youth policy framework, applying leaving no one behind (LNOB) principle in all joint activities and focusing on marginalized groups, specifically in rural areas.

# SUPPORT TO STRATEGY ON PRESERVING AND IMPROVING REPRODUCTIVE HEALTH DEVELOPMENT

In 2023 UNFPA supported development of the new comprehensive Strategy for preserving and improving reproductive health 2024-2030, by supporting ex-ante and ex-post analysis and actively participating in the work of the multisectoral working group for document development. # RAISING AWARENESS AMONG ROMA WOMEN AND GIRLS ON SEXUAL AND REPRODUCTIVE HEALTH AND RIGHTS

Within the project on improving Roma women's knowledge about sexual and reproductive health through age-appropriate education, UN-FPA, in partnership with BIBIJA - Roma Women Centre, conducted 84 age-appropriate workshops in six Roma settlements covering a range of topics such as: gender-based violence, early marriages, bodily autonomy, use of contraception, family planning, etc. Capacity of 150 women and girls were raised to exercise their sexual reproductive rights, including the right to family planning, and identify barriers that they are facing in access to healthcare services. All capacity building and awareness raising activities were led by Roma women, previously trained as peer educators. The added value of the project was de-stigmatization of the SRHR topics within selected Roma communities.

# **BODYRIGHT CAMPAIGN** "OWN YOUR BODY ONLINE!" CONTINUES

UNFPA launched the second phase of the bodyright campaign "Own your body online", during 16 Days of Activism 2023, via social media to raise awareness on the issue of bodily autonomy online. As part of the campaign, an educational Instagram quiz was conducted to educate people about the importance of bodily autonomy in online spaces. The quiz focused on different aspects of bodily autonomy, such as consent, privacy, and security, and aimed to foster a better understanding of the issue among the younger population. In December, UNFPA took part in the "World in 2023" conference organized by Color Press Group. At the panel dedicated to bodyright, together with the Ministry of Education, Commissioner for the Protection of Equality, local experts and influencers UNFPA promoted successes of the local campaign launched in 2022, localized Glossary of Technology Facilitated Gender Based Violence and united to say no to online violence.

# CAPACITY BUILDING OF YOUNG PEOPLE ON TFGBV AND BODYRIGHT

In partnership with the Commissioner for the Protection of Equality, UNFPA continued implementation of the localized UNFPA bodyright campaign "Own your body online", that was launched in 2022 in Serbia to raise awareness

about technology facilitated gender-based violence (TFGBV) and its consequences. During 2023, more than 120 secondary school students from six municipalities raised their capacity to recognize, name, report and/or respond to TFGBV and to transfer some knowledge through peer-to-peer activities in their communities. Disaggregated data shows that 60% of participants were girls compared to 40% of boys.

# YOUTH WELLBEING INDEX **DEVELOPMENT CONTINUES**

In partnership with the Ministry of Tourism and Youth, and the IP Ana and Vlade Divac Foundation, UNFPA continued development of the Youth Wellbeing Index, as a novel way to monitor the status of youth and progress in implementation of the youth policies at national and local (municipal) level. The structure of the index corresponds to the general and specific objectives of the Strategy. Methodology of the Index, including the proposed indicators, developed by the experts was considered and verified by a multisectoral working group composed of all relevant national partners, institutions and CSOs, established by the Ministry of Tourism and Youth. The proposed indicators were tested and adapted for zero measurement at national and local level that was conducted in 17 selected cities and municipalities) in late 2023 The methodology will be reviewed and fine-tuned in early 2024, before initiating the first Index measurement. The first results of the Youth Wellbeing Index will be available in the second half of 2024.

# HANDBOOK ON YOUTH WELLBEING FOR YOUTH **OFFICES AND YOUNG PEOPLE**

In line with the priority of the Ministry of Tourism and Youth to improve the mental health, life skills and well-being of young people, UNFPA, in partnership with the IP Psychosocial Innovation Network, (PIN), developed a Handbook on mental health, social wellbeing and healthy lifestyle with an aim of providing young people, youth workers and coordinators of the local youth offices with information, essential skills, practical guidance and variety of activities to enhance their daily efforts to strengthen capacities of all relevant stakeholders in this area. The Handbook includes three different modules which provide basic knowledge about the developmental characteristics of youth, challenges in interpersonal relationships and psychosocial difficulties that young people may encounter, forms of health-risk behaviors that most often appear for the first time, as well as recommended approaches for improving youth psychosocial and physical well-being. All three modules were piloted and tested in the Youth office of Kragujevac, in agreement with the Ministry of Tourism and Youth. All the materials including the Handbook were prepared in co-creation with young people.

# ADOPTION OF THE STRATEGY AND ACTION PLAN FOR ACTIVE AND HEALTHY AGING

UNFPA has supported the Ministry of Family Welfare and Demography in creating the Strategy for Active and Healthy Aging (2024-2030),

and its accompanying first Action Plan (2024-2026). Effective since January 2024, the newly adopted Strategy and the Action Plan, notably prioritize older women who are particularly vulnerable. Both documents put more focus on active and healthy aging, seeking to empower older persons as valuable community resources amidst the significant demographic shifts in Serbia. Highlighting the unique needs and potential of older individuals, the documents advocate for increased awareness among the general population. They also stress a focused approach on gender-related aspects, including improved access to public services, lifelong learning programs, sports and cultural initiatives, strengthened volunteering activities, and enhanced institutional and non-institutional protection for older persons.

# **CONSULTATIONS FOR** THE EX-POST ANALYSIS OF THE BIRTH PROMOTION STRATEGY

In accordance with its commitment to gender equality, UNFPA is supporting the process of drafting the ex-post analysis of the Birth Promotion Strategy. Comprehensive consultations involving interested stakeholders regarding the creation of the ex-post analysis for the Birth Promotion Strategy were successfully conducted on 20 November 2023. The consultations convened around 20 experts, including members of the academic community and the non-governmental sector. Their focus was on analyzing the Birth Promotion Strategy's measures and offering recommendations for the development of a new Strategy and its accompanying Action

Plan, with a consideration of gender-related factors. The outcomes of these consultations, incorporating a gender-inclusive perspective, will be integrated into the ex-post analysis of the Birth Promotion Strategy.

# SOCIAL DIALOGUES FOR STRENGTHENING **INTERGENERATIONAL COOPERATION AND PROTECTING** PERSONS WITH DISABILITIES

UNFPA provided support to the Ministry of Human and Minority Rights and Social Dialogue in organizing two social dialogues addressing the enhancement of intergenerational cooperation (22 November 2023) and the protection of persons with disabilities (4 December 2023), ensuring a comprehensive approach to recommendations that considers the diverse needs and experiences of all individuals involved. The recommendations from the social dialogues have been disseminated to relevant stakeholders for improving social policy measures.

# ICPD30 "POPULATION AND **DEVELOPMENT: ENSURING RIGHTS AND CHOICES"**

The Regional Conference on ICPD30, themed "Population and Development: Ensuring Rights and Choices," took place in Geneva from 19th to 20th October. UNFPA provided support to a Serbian Delegation led by the Minister for Family Welfare and Demography, underscoring a dedicated commitment to gender equality. The delegation actively participated in the High-level Plenary Session. For this occasion, in collaboration with the Ministry of Family Welfare and Demography and Prof. Mirjana Raševic, UNFPA contributed to the creation of a comprehensive report. This report assesses the progress of the Republic of Serbia in achieving the goals outlined in the ICPD Program of Action, with a focus on gender perspective.

# **CONSULTATIONS FOR ENHANCING SOCIAL PROTECTION SEVICES** AT THE LOCAL LEVEL

Within the new UN Joint Programme titled "PRO -Local Governance for People and Nature," three consultations were conducted to collect data for assessing local self-government capacities in improving social protection services and addressing specific user needs, with a particular emphasis on integrating a gender perspective. Over 70 participants, including representatives from the Ministry of Labour, Employment, Veteran and Social Affairs (MoLEVSA), Institute for Social Protection, and social workers from 20 local self-government units, actively participated in these consultations. This initiative aims to provide a comprehensive understanding of the capacities of local self-governments, centers for social work, and other stakeholders to establish diverse models for activating social assistance users, gradually reducing their dependence on the social protection system.

GENDER AND SMALL ARMS AND LIGHT WEAPONS CONTROL - Western Balkan Authorities Raise Institutional Capacities for Effective Prevention and Combatting of the Misuse of Firearms in Domestic Violence

UNDP SEESAC has provided comprehensive support to authorities in the Western Balkans to combat the use of firearms in domestic violence effectively. Such support includes:

• Implementation of the regional Analysis of the institutional response to the use of firearms in domestic violence,

• Development of a Tool for a gender-sensitive firearm license approval and provision of training on its use,

• Development of a Tool for first-line responders to address risks related to firearms in domestic violence and provision of training on its use.

At the end of 2022, SEESAC initiated the development of a *Tool to address the risks related to firearms in domestic violence and the Tool for gender-sensitive firearm license approval. In parallel,* SEESAC commenced the regional *Analysis of the misuse of firearms in domestic violence.* For those purposes, two regional Working Groups were established to ensure that tools and the analysis build on the extensive experience of relevant professionals.

Based on inputs and contributions from the Working Groups and focus group discussions with police officers and women's organizations held across the region, SEESAC developed draft versions of Tools. From 21 November to 14 December 2023, 10 consultative meetings in Tirana, Podgorica, Skopje, Sarajevo, and Pristina were held with the members of the Working Groups to discuss the structure and content of the Tools and propose amendments to ensure their practical application. In addition, the preliminary findings of the Analysis of the institutional response to the misuse of firearms in domestic violence were presented, and the challenges encountered in data collection were discussed. The feedback received from Working Group members on the draft version of the Tools at the consultative meetings will be used to finalize the content of the Tools and, during 2024, to conduct training of relevant police officers on the use of Tools. In addition, SEESAC continued the Implementation of the regional Analysis of the women's and men's participation in SALW control in the Western Balkans, and more than 40 in-depth interviews were conducted with relevant professionals in this field. These activities were implemented within the framework of the regional project **Support for Enhancing the** Fight Against the Illegal Possession, Misuse, and Trafficking of Small Arms and Light Weapons (SALW) in the Western Balkans, funded by the European Union through the Instrument for Pre-accession Assistance (IPA II).

The central topic of the regional meeting was the role of the Armed Forces in Gender Sen-

sitive Disaster Preparedness and Relief, which has led to a fruitful discussion and exchange of ideas, proving the importance of the regional network of gender trainers as an interactive platform for generating new initiatives. The consequences of climate change result in human catastrophes unseen before, both across the world and in the region, often involving the engagement of AFs in various capacities. The consequences of such disasters are felt long-term. Still, they most often disproportionately affect women, especially in places with low records of gender equality in which women are found in a more vulnerable position. As part of the regular knowledge sharing, the meeting also allowed the participants to reflect on past activities and achievements and update on the continuous efforts on gender mainstreaming in defence policy. The meeting enabled the launch of the online basic gender awareness course, a learning tool developed in collaboration with the four Ministries of Defense with the support of UNDP SEESAC.

# EU PRO Plus - The European Union Local Development Programme

The EU PRO Plus Programme is strongly contributing to strengthening of women entrepreneurship and employment of women through continued support to the business sector. In September 2023, the Public Call for Proposals for Supporting Women and Youth Start-ups was concluded, covering 43 underdeveloped municipalities. The evaluation process was completed at the end of 2023, resulting in 45 start-ups endorsed for funding, 64% of which are owned by women. They will be supported through procurement of equipment and introduction of services. As a result of grant support to entrepreneurs, micro and small enterprises, a total of 270 new jobs have been created until now and 52% are occupied by women.

Within the efforts to improve social infrastructure and social cohesion, the EU PRO Plus continued to facilitate access to different public services for marginalised and vulnerable groups. For seven local infrastructure projects, the gender dimension was recognised by a number of capacity-building workshops, and sports activities supporting women involvement in the social and economic activities. In Lapovo, four capacity building workshops empowered 32 women from the rural areas to diversify economic activities. In Knjaževac,

90 girls of primary school age were invo in sports activities. # EUSHAI - Contribution to improved living conditions for the most vulnerable groups

**19<sup>TH</sup> ISSUE**:

The EU SHAI Programme has made significant strides in improving living conditions for the most vulnerable women and men, girls and boys by implementing 19 grant projects in LSGs. Through these projects, housing solutions and social inclusion measures are being provided to 381 vulnerable families, comprising over 1,400 family members (Roma, persons with disabilities (PWDs), women victims of domestic violence, youth leaving the social care system). Eighteen (18) families were moved in the constructed social housing flats in Raška in August 2023 and 14 families in the newly constructed individual housing unit in Koceljeva and Žagubica, bringing a total of 141 families accommodated in the constructed housing units, 62 families moved to the purchased properties, while 104 privately owned houses were reconstructed, or in total 307 families with 1,033 family members (482 male and 551 female). All women are legally registered owners/users of the housing support solutions, together with their spouses and partners.

Gender mainstreaming is an integrated part of the projects and up to this period, 331 families have been selected with 1,142 family members, out of which 601 are female and 541 are male. Temporary work engagement is provided in five LSGs for 42 beneficiaries (16 male and 26 female), 29 beneficiaries (7 male and 22 female) acquired employment or self-employment, in 13 LSGs, 324 beneficiaries (104 male and 221 female) have finalised VET training. Up to date, 819 (372 male and 447 female) beneficiaries have been assisted with a variety of active inclusion measures. Thirty two women victims of domestic violence with their families are supported with social housing apartments and individual houses in ownership so far.

The impact of comprehensive training programmes on 134 employees (102 women, 32 men) has been significant. Among these projects, social measures reproductive health and reduction of adolesand services were established specifically tarcent pregnancies. and provided support for their professional orientation. Currently, 60 Roma women attended workshops on reproductive health while 17 young Roma women are going to multi-sector counselling provided by gynaecologist, psychologist and social worker.

• Project "For a Life Without Violence" in Leskovac, implemented by Romani Women from Leskovac, conducts an extensive campaign and education about gender-based violence in seven Roma settlements in Leskovac, in partnership with the CSW. Currently, 33 Roma women attended workshops on domestic and partner violence.

# ADVANCING GENDER EQUALITY AND COUNTERING GENDER-BASED DISCRIMINTAION: Ending violence - Empowering change

A new project implemented jointly by four UN agencies - UNDP (lead agency), UNICEF, UN Women and UNFPA in partnership with the Government of Serbia and the Coordination Body for Gender Equality, with support of the Government of Sweden, yielded from the results of the years-long efforts focusing on ending violence against women and girls. The new "Ending violence – Empowering change" project, to be implemented from January 2024 to end of 2026, moves beyond elimination of gender-based violence and seeks to advance gender equality by addressing the root causes of inequality. It will challenge harmful norms and stereotypes and strive to create a society where gender-based violence and discrimination are unacceptable, women's rights are protected, and women can fully participate and contribute to all aspects of social life. Our focus is on the needs and perspectives of women and girls, including those from vulnerable groups, such as Roma girls,

women with disabilities, elderly women, women from rural areas. Bearing in mind the complexity of gender-based discrimination, the project will work at various levels — individual, community and society, engaging national to local level stakeholders.

# **FROM STIGMA TO PREVENTION** - REDUCING FIREARMS MISUSE FOR DOMESTIC VIOLENCE AND SUICIDE

UNDP efforts to reduce firearms misuse for domestic violence and suicide in Serbia are continued through the recently initiated project "Reduce Risk - Increase Safety III". In Serbian society, firearms are misused for suicide - largely amongst men - while women are predominantly the victims of firearm-related domestic violence. The project's undertaking is made more challenging by the stigma associated with domestic violence and mental health issues, coupled with often inadequate **<u>reporting</u>** by media outlets. This atmosphere discourages individuals at risk from seeking necessary help. The mass shootings in Serbia in May 2023 strongly pointed to the urgency of addressing these issues and spotlighted the need for improved institutional and community responses to such situations. This project aims to alter negative societal norms that can lead to firearm misuse. Further objectives include strengthening the gender perspective in small arms and light weapons (SALW) control policies, elevating women's roles in these policies, and improving community response to firearm-related incidents. From October 2023 to October 2025, the project will focus on:

• bolstering institutional data collection practices to advance evidence-based policy making,

ensuring that firearm misuse risks are included in regulations addressing domestic violence prevention,

• facilitating women's active participation in SALW control policies,

 helping professionals better identify and prevent potential firearms misuse, and

increasing public awareness of the impact of practices leading to firearm misuse. The project kicked off with a **joint event** hosted by the Ministry of Interior and Network of Women in the Police of the Republic of Serbia during the "16 Days of Activism" campaign, which saw representatives from 29 local police departments sharing practices related to domestic violence prevention, including cases involving firearms misuse.

# DISTANCE LEARNING PLATFORM OF THE JUDICIAL ACADEMY LAUNCHED

With the support of UNDP, the Judicial Academy of the Republic of Serbia launched its online learning platform in October 2023, along with seven training modules in the field of prevention of and protection from domestic violence. The platform enables judicial professionals to access various trainings and materials. The modules on domestic violence prevention are part of the obligatory professional training of public prosecutors, their deputies and judges that engage in the proceedings under the Law on the Prevention of Domestic Violence. They cover topics such as recognizing different forms of domestic violence, assessment of violence escalation and repetition risk (including risk of firearms misuse for violence), as well as multi-agency action to ensure long-term safety for victims, proving the criminal act of domestic violence, and international obligations. These modules of the Judicial Academy are also accessible to employees of the police, health care

workers and centers for social work. In the first three months since the platform's launch, over 2700 users were registered.

**TOGETHER AGAINST GENDER BASED PREJUDICES** 

For the fifth year in a row, UNDP implemented its #TiceMeSe (#ItIsMyBusiness) campaign. The focus was on **countering prejudices** and gender social norms limiting both women's and men's choices and opportunities in private and public life. The campaign presented findings of UN-DP's 2023 Gender Social Norms Index, showing that 76% of Serbian citizens have at least one prejudice about the roles of women and men in society. The social media campaign, reaching nearly 120 000 people, presented everyday life situations in which women face prejudice regarding their political participation, their right to economic independence and safety from violence and discrimination.

# WHAT'S IN MY BAG?

In collaboration with the **<u>Fempower</u>** initiative, UNDP supported <u>a photo exhibition</u> showcasing different items women carry in their bags for protection. From pepper spray to sharp keys, the exhibition drew attention to the fact that women still do not feel safe in public spaces and acknowledged women's strength to defy their fear and speak up for gender equality.

# SUPPORTING WOMEN THROUGH A JUST GREEN TRANSITION AND REDUCTION OF ENERGY POVERTY

UNDP, the Ministry of Environmental Protection and Ministry of Mining and Energy have chosen 12 innovative business **solutions for just green** transformation of the economy and reduction of energy poverty, which will be implemented with the financial support of the Government of Japan. The selected innovations were proposed by companies from the private and public sector. By transitioning to the use of different renewable energy sources, they will contribute to the reduction of greenhouse gas emissions (GHG) and decarbonization, as well as more efficient use of natural resources. The implementation of these solutions will also lead to the opening of new, green jobs for members of vulnerable and less employable population groups. For example, one of the selected innovations is by the company "AY-YA Products" from Šid, which produces cold-pressed hazelnut oil. They are training women from vulnerable groups to work on new machines that will allow more than 80% of raw materials to be used in production, thus significantly reducing the amount of waste. Another solution is by the company "Mizan Line", which produces undergarments and sleepwear, and is replacing the use of fossil fuels in its plant in Sjenica with a solar power plant and a water-to-air heat pump. Two sources of

renewable energy enable sustainable business practices, which is of immense importance for the Sjenica region, a remote mountain town, employing predominantly women. These solutions will be implemented by March 2024.

# STRIVING FOR GENDER EQUALITY IN THE DIGITAL WORLD

To prepare primary school girls and boys for the future and the jobs it may have in store for them, during July and August 2023, the Petlja Foundation organized the **Summer school of Programming**, with support of UNDP. This oneweek intensive programme provided boys and girls aged 11 to 14 with an opportunity to delve deeper into the world of programming and to gain insight into the professions related to new technologies through conversations with IT industry professionals. The school offered a safe environment in which they could work together with their peers, learn from each other and exchange experiences. Learning was complemented with different recreational activities. Out of one hundred attendees, 23% were girls, who could find inspiration and encouragement to pursue further education and careers in programming. The 2023 cycle of the IT retraining programme was completed in August. Attendees who wanted to improve their skills necessary for the position of IT junior programmer,

participated in a 9-month programme that involved training in programming and gaining practical skills in IT companies. In addition, the programme supported participants to improve soft skills necessary for successful participation in the labour market. A total of 362 people attended the IT retraining programme, of which 159 (44%) were women, who enhanced their chances for employment in this fast-developing and sector with high earnings. This program is organized by the Office of the Prime Minister in partnership with the Ministry of Labour, Employment, Veterans and Social Affairs and the Office for Information Technologies and eGovernment, in cooperation with UNDP.

<u>Al and gender equality – or reproducing in-</u> equalities, was the title of a panel discussion organized by Ringier Serbia media company in December 2023, as part of the first "Equal Voice-Seeing is Believing" conference aiming to increasing the visibility of women in the media as expert interviewees. UNDP Serbia Gender Portfolio Manager Maja Brankovic Djundic spoke as one of the panelists, alongside philosopher Vladimir Đukanovic, World Bank expert Sanja Vraneš and Brankica Jankovic, Commissioner for Protection of Equality. The discussion focused on the ways Al system reflects and impacts gender bias and how to avoid gender-based prejudice and discrimination reflected through innovative technologies in the future.

# **EMPOWERMENT GOES LOCAL**

Within the Regional Programme on Local Democracy in the Western Balkans 2 (ReLOaD2) funded by the European Union, twenty-nine **<u>Civil Society Organizations (CSOs)</u>** received funding for implementing various activities in seven cities and municipalities in Serbia. Most of their beneficiaries are women and girls, with over 60% of the projects focused on their welfare and four projects entirely dedicated to women's empowerment. In Vladicin Han, CSO Home Assistance for the Elderly will provide training for fourteen elderly care housekeepers. These women will be educated to provide home assistance services, empowering them for work opportunities, as well as contributing to local care needs. The organization CenTrir in Oplenac has **initiated a five-month program to** train 15 women, aiming to enhance farmers' abilities to apply sanitary and hygienic standards and sell their products effectively. The CSO Anahitas is focusing on the mental well-being of pregnant women and women after labor. They have conducted individual consultations and will hold workshops for recognizing and preventing postpartum symptoms. The program also includes training for new mothers, preparing them to manage parenting challenges more effectively.

# ENDING CHILD MARRIAGE

Direct support to the National Coalition to End Child Marriage (NCECM) provided by UNICEF enabled a continuity of work by this forum which remained critical for bringing together key stakeholders for eliminating the practice. The Coalition continued to advocate for regulatory changes and the government publicly committed to amend two laws to ban child marriage and secure sanctioning of perpetrators. NCECM initiatives in the reporting period encompassed learning about interconnectedness between child marriage and statelessness in the country. On 26 September, UNHCR & UNICEF hosted in the UN House in Belgrade the 12th Meeting of the National Coalition to End Child Marriage, the aim of which was to discuss the connection between child and early marriage and statelessness in order to inform key actors and to draw attention of the public to this negative phenomenon. The efforts and the results of the national authorities on ensuring birth registration and activities of the civil society organisations on combatting child, early and forced marriages (CEFM) and statelessness were presented and discussed.

The national efforts to eliminate child marriage were recognized at a High-Level Side Event during the Seventy-Eighth Session of the United Nations General Assembly on 21st September 2023. The event, titled 'Charting Brighter Futures: Utilizing Data for Accelerated Action to End Child Marriage and Achieve SDG 5.3,' was a unique opportunity to dive into the power of data, engage in discussions on its utilization, and explore actions to fulfill the rights of girls everywhere. Leaders from the Governments of Canada, Zambia, Serbia, Nigeria, the United Kingdom and the United States spoke about their commitment to ending child marriage. The event was hosted by the Governments of Canada and Zambia, in partnership with the UNFPA-UNICEF Global Programme to End Child Marriage and the Child Marriage Monitoring Mechanism. Serbia was represented by the Minister of Family Welfare and Demography (quoted below).

In the reporting period National Coalition to End Child Marriage developed and distributed two newsletter issues (September and December, respectively) as a tool to communicate the main achievements and information on the most relevant activities and results of the member organizations (such as good practice examples, success stories from the state institutions, CSOs, local community leaders in child marriage prevention and relevant ministries). Newsletters can be accessed on the link here and here.

To secure continued support to synergetic efforts, support to the NCECM and strengthening Roma girls' and women leadership was mainstreamed into the Joint-UN three-year programme (starting in 2024) promoting gender equality and prevention of GBV.

# MATERNAL, CHILD HEALTH AND BREASTFEEDING

Endorsement of epidemiological guidelines enabling the presence of mothers and parents in Neonatal Intensive Care Units created a positive environment for improving quality of neonatal health care in Serbia. As a member of national expert working group for improving conditions in maternity wards, UNICEF got the opportunity for strong advocacy for humanization conditions during delivery, including active participation of partners during childbirth. Moreover, on the occasion of the World Prematurity Day, in November 2023 a **brochure for parents** of prematurely born children was released by the Institute of Neonatology in Belgrade with the support of UNICEF with the aim to empower mothers and fathers for nurturing first contacts with babies while in neonatal intensive care units (on family oriented developmental care: eg. on skin-to-skin contact, cuddling, reading and responding to child cues, etc).

# **GENDER-RESPONSIVE** PARENTING PROGRAMME

Parental emotional well-being and father engagement more and more in the focus of innovated home visiting nurse practices of work with families of young children. Over 120 home visiting nurses from Serbia are capacitated for providing support to mothers and fathers in dealing with parental stress, improving resilience and responsiveness in child-parent dads, in organizing family routines with children and play activities from the very first day of life of a child (through an intensive UNICEF capacity building program "Caring for the Caregiver" which is implemented as part of the Playful Parenting Program supported by the LEGO Foundation). UNICEF partnered with the Association of Home Visiting Nurses of Serbia in reaching the shared goal - improving understanding, standards and skills of Early Childhood Development practitioners across Serbia in delivering culturally and gender sensitive, high-quality integrated early childhood development and parenting support programs for all children from conception to 6 years of age. Building responsiveness and gender-balance support services increase the likelihood that parents will engage in responsive, warm, play-based interactions with their children.

# INCLUSIVE EDUCATION MONITORING FRAMEWORK – IE MONITORING AT THE LOCAL LEVEL

The first comprehensive IE Monitoring Framework, developed in 2014, has been revised with the indicators, descriptors, and mechanisms for inclusive education monitoring at the local level. Indicators targeting the position of girls, and implementation of the principles of gender equality, are included in the revised IE Monitoring Framework. The revised IE Monitoring Framework is in the process of setting up at the national level, and is being implemented in 20 municipalities, to inform the new local inclusive policies.

# GENDER-BASED VIOLENCE IN EMERGENCIES (GBViE)

UNICEF supported direct GBV prevention and response services for refugee and migrant women, girls, and boys in three asylum and reception centers, one safe hub in Belgrade city center, and for Ukrainians in private accommodation. Collaborating with the two implementing partners, Info Park and Danish Refugee Council, UNICEF reached 1,114 children and their caregivers. Services encompassed outreach, prevention, and psychosocial support, with a focus on survivors or individuals at risk of GBV. Activities included workshops, info-sessions, individual support via hotline, safe referrals, and case management for GBV cases.

UNICEF has continued to distribute dignity/hygiene kits for purposes of mitigating GBV risks reaching 875 beneficiaries including 315 unaccompanied and separated boys in this period. The kits included key hygiene and other vital items for women, girls and boys accommodated in reception and asylum centers, social protection institutions and NGO shelter. GBV info materials have been distributed to beneficiaries accommodated in all locations, reaching over 114 women, girls, and boys. UNICEF and Danish Refugee Council in cooperation with Serbian Commissariat for Refugees and Migration organized 3-day training for 33 local trustees for refugees working together with them to strengthen their capacities to work with displaced populations and contribute to response to gender-based violence, human trafficking, child protection violations and other protection challenges.

# **FIGURES AND STATISTICS**

Among the 22,999 newly arrived persons observed between 1 August 2023 and January 2024, 90.7% were men, 5.9% were children, including 220 UASC, and only 3.4% were women. As per Serbian Commissariat for Refugees and Migration (SCRM) data, at end-January 2024, 1,212 refugees, asylum-seekers and migrants were accommodated in 11 governmental asylum/reception/transit centers, of which 1,000 men (85.7%), 72 women (6.2 %) and 95 children (8.1%). Meanwhile 29% of all the children recorded in the centers were UASC (28). 2 persons were granted refugee status during the reporting period. UNHCR and partners provide legal assistance and an individualized integration support to recognized refugees.

# **UKRAINIAN RESPONSE**

Since the escalation of conflict in Ukraine, the Serbian Ministry of Interior (MOI) has noted a total of 327,219 persons who fled the country and entered Serbia. At end-January, 45 refugees from Ukraine were accommodated in Vranje Asylum Center, run by SCRM. Between August 2023 and January 2024, a total of 188 Ukrainians (69 men, 92 women, 10 boys and 17 girls) requested temporary protection (TP), 195 were granted the TP, and 12 TP were extended during the period considered.

# LOCAL COMMUNITY INITIATIVES

Inclusion of refugees, asylum-seekers, IDPs and persons at risk of statelessness in community activities promotes inclusion and peaceful coexistence. UNHCR focuses on promoting their human capital, and on linking them with the local authorities, schools, youth, cultural centers and municipalities, and on supporting joint projects. ma Plus supported the participation of five Ukrainian refugee women in a culinary event in Bela Palanka held on August 13. The women presented the Ukrainian national cuisine at the event attended by more than ten thousand visitors.

- "Dani Vranja": Ukrainian refugees showcased their traditional handicrafts, crafted during Sigma Plus workshops, at the "Days of Vranje" event on August 30. Visitors had the opportunity to appreciate the beautiful creations and traditional sweets skilfully made by Ukrainian women. The event provided a chance for attendees to become more acquainted with the cultural traditions of southern Serbia. - Women's Run: On October 1, 2023, UNHCR

and its partner DRC facilitated the participation of 11 refugee women from Burundi and Russia in the Women's Run, an annual event organized by the Belgrade Marathon. This opportunity for inclusion and recreation for refugees was made possible through the ongoing collaboration between Belgrade Marathon Ltd. and UNHCR.

- Two Deli Monday events (10 in total in the past three years of this initiative's existence) were organized by UNHCR/CRPC, the Italian Embassy in Serbia, and the School for Hospitality and Tourism from Belgrade at KC Grad. The event in was part of the Italian Cuisine Week, and attendees had the pleasure of savoring delicacies from Italy and Serbia. The delectable dishes were skillfully prepared by an Italian chef, local students, and two refugees from Iran and Syria. The two events drew over 320 visitors, including locals, representatives from various foreign and local organizations, as well as refugees and asylum-seekers.

- "Plavi krug oko Ade": UNHCR Partner CRPC participated in the "Plavi krug oko Ade" Race on November 12 and supported a refugee woman from Ukraine who took part in the race. Over 900 individuals from the local and international community joined the event to contribute to the fight against diabetes.

# **16 DAYS OF ACTIVISM AGAINST GBV**

UNHCR collaborated with the City of Novi Sad, Cultural Centre of Novi Sad, the Novi Sad Technical School of Hospitality, local NGOs, and various UN agencies to organize on November 27, a themed event titled "Bridges of Hope: Brushstrokes of Resilience against Gender-Based Violence." This initiative aimed to reinforce the message that UN Serbia actively supports collaborative efforts for the prevention of sexual and gender-based violence (SGBV). The event also emphasized the promotion of responsive mechanisms inclusive of all women and girls in the country, be they local or refugees. Well-attended by representatives from local self-governments at the city and provincial levels, the event was organized under the auspices of the UN Resident Coordinator in Serbia.

- On November 28, high school students in Bosilegrad, prompted by Sigma Plus, actively supported the 16 Days of Activism Campaign by delivering a presentation titled "Gender-based violence - does it concern me?" at their school. They engaged in a group discussion with refugees and asylum-seekers residing in the Reception Centre Bosilegrad, focusing on the topic of gender-based violence within the premises of the Integration Corner with Library (IKB).

The collaborative effort resulted in paintings that depict their personal experiences with gender-based violence. The painting workshop was facilitated by a local female artist, marking the beginning of a partnership between Sigma Plus and the artist. Notably, all participants adorned orange ribbons crafted by Ukrainian refugees residing in Vranje.

- A workshop titled "Building Bonds through Movement and Circus Arts for a Safer Community" was organized by partner DRC in Belgrade on November 30.

- CRPC organized a PSEA Training for refugees and asylum-seekers residing in private accommodation at Prostor Miljenko Dereta in Belgrade on December 3.

- On December 4, the BCHR conducted a round table addressing the circumstances of SGBV and LGBTIQ+ refugees and asylum-seekers in observance of the 16 Days of Activism Campaign. This event served as a continuation of the BCHR's series of focus groups involving representatives from state institutions and Civil Society Organizations (CSOs). Through a multisectoral approach and insights from various perspectives, these focus groups analyzed the specific challenges faced by SGBV and LGBTIQ+ individuals. They collaboratively formulated guidelines, which had earlier garnered support from many participants, aimed at enhancing the situation of these groups in Serbia.

- Partner International Aid Network (IAN) organized an educational quiz "Sve u 16" on November 27, in Café Bar 16, a social enterprise that employs children who previously lived and worked on the streets. It contained questions that checked and improved the knowledge of the participants about women's rights, the position of women and other vulnerable groups. The event was attended by refugees and asylum-seekers from African countries, Cuba, and Syria.

- As part of the 16 DoA against GBV Campaign, IAN conducted complimentary gynecological examinations in Belgrade, Bosilegrad, and Vranje for 28 female refugees and asylum-seekers.

# WOMEN LEADERSHIP AND **GENDER EMPOWERMENT IN REFUGEE COMMUNITIES**

In order to reduce risk of Gender-Based Violence (GBV), to promote resilience and to aid recovery of communities, UNHCR and its partner Danish Refugee Council (DRC) implemented a range of activities primarily focused on women and girls. These activities encompassed: identification of GBV survivors, empowerment activities, health raising awareness and protection monitoring. A total number of 10 GBV survivors, with 3 be-

ing newly identified cases, were provided assistance, and referred to specialized services. Legal assistance, including in-court representation, have been provided to the GBV survivors. During the reporting period, DRC, supported by UNHCR, held a total of 56 activities for refugee and asylum-seeking women accommodated in Krnja a Asylum Center, hosted mostly in the Women Safe Space within the asylum center. The core objective of these initiatives was to advance women's rights, encompassing the right to seek asylum, preventive measures against GBV, health-oriented awareness programs, and a spectrum of other subjects.

# CHILD, EARLY AND FORCED MARRIAGES (CEFM)

On 26 September, UNHCR & UNICEF hosted in the UN House in Belgrade the 12th Meeting of the National Coalition to End Child, Early and Forced Marriages, devoted to linkages between statelessness and child marriages, but also the efforts and the results of the national authorities on ensuring birth registration and activities of the civil society organizations on combatting CEFM and statelessness.

With regard to activities addressing CEFM, UNHCR partner Praxis conducted four CEFM workshops for schoolchildren in primary schools in Tovariševo (Municipality of Ba ka Palanka), Kostolac, Veliki Crljeni (Municipality of Lazarevac), and Leskovac. A total of 198 pupils (125 girls and 73 boys) attended these workshops and learnt of the links between CEFM and risk of statelessness. These workshops aimed at raising awareness of children regarding the potential hazards associated with CEFM, through engaging discussions on children's rights, the significance of education, early school drop-out concerns, the needs and obligations during their formative years, and discussions on parental roles and responsibilities in marriage. Praxis further organized four meetings in schools, engaging with directors,

# **International Youth Day**

On International Youth Day, UNFPA and UN Women kicked off the social media campaign #Mladi-Govore (#YouthHaveTheirSay), which is implemented under the JP "Peer Mentoring Program for promotion of human rights, gender equality and increased youth participation in Serbia", supported by the Italian Embassy. A series of peer workshops and activities with youth in four local municipalities - Novi Pazar, Kragujevac, Sremski Karlovci and Sombor, took place on the occasion of International Youth Day. Local activities were promoted on social media, as well as traditional media through press release with the RCO and the Italian Embassy.

Additionally, UNFPA and Ministry of Tourism and Youth shared a press release on 12 August with a quote from the Assistant Minister and UNFPA Head of Office that featured key statistics and priorities in this area. 13 media hits were reported via press clipping.

# **World Contraception Day**

# **16 Days of Activism against Gender-Based Violence**

UN Serbia GTG and Communications Group organized two joint events and a social media campaign to mark 16 Days of Activism against Gender-Based Violence against Women and Girls. A joint event "Imagine Life without Violence" focused on youth and GBV was organized 24 November in Belgrade, spearheaded by UNDP as Deputy GTG Chair. The event included a presentation of findings from the joint regional research on social cohesion, gender equality and peacebuilding, followed by a moderated discussion. An event "Bridges of Hope: United in the fight against gender-based violence" focused on refugee women and girls, was organized on 27 November, in Novi Sad by UNHCR and RCO, featuring joint cooking, musical performance and mural painting. Both joint events were attended by high government officials, donors and international community. UN agencies also organized other events targeting different communities, showcased in a detailed calendar of all UN agencies' events for 16 DoA against GBV which was shared on social media. For instance, UN Women organised a national conference "The right to inheritance – a Path to Gender Equality and Ending Violence" was in the Palace of Serbia. On this occasion, a guide "The rights to inheritance - equal to all", jointly created by the Commissioner for the Protection of Equality, UN Women and Center for Research and Social Development IDEAS.
